**Eligibility of Competitors:** In accordance with Rule 1.6 and/or the definitions in Section 2 of the NRA Pistol Rules. Note: As of July 1<sup>st</sup>, 2008, NRA Membership is encouraged, but not required.

**Open to:** Service, Police and Civilian NRA members.

Teams will consist of four (4) firing members, one alternate, a captain and/or coach. The teams must conform to NRA Rule(s) 2.10 – 2.20.

**Entries:** Limited to one relay (58 Shooters). Slots will not be held without a completed registration form! Register using the attached entry form. Include personal or commercial check payable to Garrison R&R Club, money order, or NRA points with entry form.

**Entry Close:** Individual match entries must be received no later than Monday, June 22, 2009.

**Post Entries:** Post entries will be accepted up to the stated limit of the range.

**Rules:** Current NRA Conventional Pistol Rules will govern.

**Classification:** The NRA classification system will be used in all matches. Individuals who have not been classified will fire in the Master Class. (Rule 19.6 Assigned Classification may be used.)

**Challenges:** A challenge fee of \$1.00 will be charged for each challenge made. Challenges will be judged and validated by a designated 3 person jury.

**Awards:** Awards will be given to the open winners in each of the 16 matches. A first place award will be given provided there are five (5) or more competitors in a class and category. A second and third place award will be given provided there are ten (10) or more competitors in a class and category.

NRA award points will be forwarded to the winners.

Additionally, the NRA will provide first, second and third place open awards in the Grand Aggregate in the form of Gold, Silver and Bronze medallions.

**Souvenir Award:** Each competitor will be issued a regional souvenir.

**Safety Notices: Alcoholic Beverages are Strictly Prohibited! Anyone believed to be under the influence of alcohol will not be allowed to compete.**

**Eye and ear protection must be worn.**

**The use of the Open Bolt Indicator Flag or an equivalent device is mandatory at this range. When the command “Cease Firing” is given, the flag will be inserted immediately.**

**Saturday’s Matches:** Firing will commence promptly at **9:00 A.M.** with the 22, followed immediately with center fire matches. Team and D.R. matches will follow the Center Fire Match.

# Marriottsville Match July 4-5, 2009

## TEAM MATCH ENTRY FORM

The maximum number of competitors on each team's roster will be six (6) from which only four (4) members will fire for score. Team classification will be determined by the classification of the firing members in accordance with NRA rule 19.12.

In accordance with NRA rule 2.10, entries will not be accepted from "pickup" teams. In accordance with NRA rule 2.12, state association teams must be authorized and said authorization shall be signed by the state association president, vice-president, or secretary.

In accordance with NRA rule 2.11, all members of club teams, including team captain and coach, must have been fully paid members of the club that the team represents for a period of at least 30 days prior to the competition. The club must be affiliated with the NRA and in good standing.

In accordance with NRA rule 2.2, active duty Air Force, Marine Corp, Coast Guard, Army, and Navy personnel; members of Reserve components on active duty; and retired personnel of the services comprising the Armed Forces of the United States on active duty, are not permitted to compete as civilians. However, if the Armed Forces are NOT supporting your shooting, i.e. by supplying guns, ammunition, or paying for your match fees or travel, you may compete as a civilian and as civilian team or team member. This is specifically authorized by this Tournament Program, Rule 2.2; Para. 3.

For recognition of fired records, scores are submitted in three categories, Service, Police, and Civilian as indicated on the entry form. For award purposes, all teams will compete by NRA classification. Awards by classification will be issued to the winner of the grand aggregate. Four teams are required to form a class.

**Entries will be accepted only with full payment for the entire team.**
