NRA Registered 2700 Aggregate Matches:

Sunday April 11, Saturday May 8, Saturday and Sunday June 12 and 13
(**Maryland State Championship**), Sunday August 8, Sunday September 12 (**The Chesapeake Bay Regional/Fifth Annual Claude Veillon Memorial Match**) and Sunday October 10
(**AAFG/12PPC Ironman**) 2010.

CMP Excellence in Competition matches and NRA Distinguished Revolver matches will be fired at the **State Championship** and **Regional** matches.

Open to: Anyone wishing to enter the competition.

Entries: Limited to one relay (36 Shooters) each day. Competitors are encouraged to pre-register for the matches to ensure a place on the firing line.

Register using the NRA form SR-1. Include personal or commercial check payable to Twelfth Precinct Pistol Club, money order, or NRA points with entry form. Post entries will be accepted up to 30 minutes of match start time provided space is available.

Registration and entry fees:

Monthly matches: \$15.00 (1 gun), \$25.00 (2 guns), \$35.00 (3 guns).

State and Regional Championship matches: \$25.00 (1 gun), \$35.00 (2 guns), \$45.00 (3 guns)

CMP Excellence in Competition Match: \$10.00

NRA Distinguished Revolver Match: \$5.00

Note: The entry fee includes the NRA registration fee.

Lunch: Will be available at reasonable cost at all matches.

Rules: Current "NRA Conventional Pistol Rules" and "CMP Competition Rules" rulebooks will govern the conduct of these matches.

Classification: The NRA classification system will be used in all matches. Individuals who have not been classified will fire in the Master Class. (Rule 19.6 Assigned Classification may be used.)

Challenges: A challenge fee of \$1.00 will be charged for each challenge made. Scoring challenges will be resolved by a designated 3 person jury if a NRA referee is not assigned to any of these matches.

Awards: A first place award will be given provided there are five (5) or more competitors in a class and category. A second place award will be given provided there are ten (10) or more competitors in a class and category. Awards will be forwarded to winners by check or NRA award points.

At the **Maryland State Championship Match**, the highest scoring resident of the State of Maryland will earn the title of Maryland Conventional Outdoor Pistol State Champion.

At the **Chesapeake Bay Regional/Second Annual Claude Veillon Memorial Match** the NRA will provide first, second and third place Open awards in the form of Gold, Silver and Bronze medallions. Additionally, the NRA will provide certificates providing 50% off National Match entry fees to the highest scoring competitor in each class at the regional. These certificates will be awarded in accordance with the NRA policies in effect at the time of the match.

Safety Notices: Alcoholic Beverages are Strictly Prohibited! Anyone believed to be under the influence of alcohol will not be allowed to compete.

Eye and ear protection must be worn.

The use of the Open Chamber Indicator flag or an equivalent device is mandatory in accordance with NRA rules. When the command "Cease Firing" is given, the flag will be inserted immediately.

Time of first match: Firing will commence promptly at **9:00 A.M.** with the .22 matches, followed by the center fire matches. There will be a break for lunch for approximately 45 minutes between the center fire and the .45 matches.

.22 Caliber Individual Matches

- Match 1 20 Shots Slow Fire, 50 yards
- Match 2 National Match Course, (10 shots slow, 10 shots timed, 10 shots rapid fire)
- Match 3 20 Shots Timed Fire, 25 yards
- Match 4 20 Shots Rapid Fire, 25 yards

Center Fire Individual Matches

- Match 6 20 Shots Slow Fire, 50 yards
- Match 7 National Match Course, (10 shots slow, 10 shots timed, 10 shots rapid fire)
- Match 8 20 Shots Timed Fire, 25 yards
- Match 9 20 Shots Rapid Fire, 25 yards

.45 Caliber Individual Matches

- Match 11 20 Shots Slow Fire, 50 yards
- Match 12 National Match Course, (10 shots slow, 10 shots timed, 10 shots rapid fire)
- Match 13 20 Shots Timed Fire, 25 yards
- Match 14 20 Shots Rapid Fire, 25 yards

Aggregate Matches

- Match 5 Aggregate of matches 1 through 4
- Match 10 Aggregate of matches 6 through 9
- Match 15 Aggregate of matches 11 through 14
- Match 16 Aggregate of matches 5, 10, & 15 (Grand Aggregate)

CMP EIC and NRA DR matches will be fired concurrently at the State Championship and the Regional matches immediately after Match 14. Two relays, or more if necessary, will be fired to ensure anyone who wants to shoot both matches will have the opportunity. Pistols, revolvers and ammunition will be inspected and triggers weighed at the EIC and DR matches.

There usually are "loaner" service pistols and revolvers available if you would like to compete in either of these "leg" matches but do not yet own a suitable weapon.

Targets: Slow fire will be fired on NRA B-6 Targets.

Timed and Rapid fire will be fired on NRA B-8 Targets.

Ironman Match: The October 10 match will be the 12th PPC stage of the Anne Arundel Fish and Game Club/ Twelfth Precinct Pistol Club "Ironman" match, the other stage having been fired at the AAFG range. No special entry fees or procedures are necessary, if you shoot both matches you are automatically entered. The highest scoring combined aggregate of the two matches will win the title of "Ironman". There will also be awards in each class providing there are enough shooters entered.

Directions: The Twelfth Precinct Pistol and Archery Club is located at 450 Harwood Road, Harwood, MD (do not send mail to this address). From Annapolis MD take RT 2 South to Harwood. Turn right on Harwood Road at the traffic light at the intersection of RT 2 and Harwood Road. The Harwood Market/CITGO gas station is located at this intersection. The Twelfth Precinct Pistol and Archery Club will be on the right about 1.4 miles down Harwood Road. The clubhouse telephone number is (410) 867-0560.
