2010 Schedule



1. **2010 Match Dates:** 24 April, 29 May, 26 June, 28 August, 25 September, 23 October, and 27 November. We will not shoot in July so competitors may attend the Nationals at Camp Perry. We will not shoot in December or January due to Holidays and cold weather.
2. **Sponsoring Club:** Mid-Carolina Gun Club of Orangeburg, SC (***NOTE: THIS IS NOT MID CAROLINA RIFLE CLUB***)
3. **Directions:** Take exit 139 on I-26, from Columbia or Charleston. Go Southwest past Wilco Truck Stop and proceed STRAIGHT at stop sign (SC Rt. 22, Burke Road). About 2 miles, turn RIGHT at road's end onto Kennerly Road. After ¼ mile RV entrance is on LEFT at the corner of Kennerly Rd. and Pine View Lane. Lat. 33.62085/Lon. -80.9229
4. **Open to the Public:** NRA membership is not required; however, scores will not be reported to the NRA unless you have a membership.
5. **Entry fees:** \$30.00 for the 2700—inclusive of lunch
\$15.00 for each 900—inclusive of lunch
\$15.00 for the 2700—inclusive of lunch. A new shooter, classified as such, may shoot .22 caliber for the 2700.
6. **Registration:** Registration starts at 08:30 a.m., and shooting will commence at 09:30 a.m. After the Center Fire match, there will be a one hour break and lunch will be provided at the Club's pavilion. The .45 match will start when lunch is finished. There is an Arby's at the interstate at Exit 139, approximately 2.5 miles from the range. Additional choices may be found at Exit 145.
7. **Advanced Entries:** Entries can be sent in advance to Wesley Pierce, 117 Balbriggan Dr., Goose Creek, SC 29445. NRA SR-1 card must be enclosed with advanced entries. Make checks payable to: Mid-Carolina Gun Club.
8. **Firing Time:** 9:30 A.M.
9. **Rules:** NRA Outdoor Conventional Pistol rules will be the governing rules for the match.
10. **Targets, Scoring, and Challenges:** Competitors will hang their own targets (50 yard B-6 and 25 yard B-8), score and replace. All strings of fire will be scored after 10 shots. Use of overlays is permitted. Use of plug type scoring gages will be restricted to range personnel and members of the Jury. The fee will be \$1.00 per challenge, returnable if upheld.

- Match 1:** 20 shots Slow Fire at 50 yards
Match 2: National Match Course
Match 3: 20 shots Timed Fire at 25 yards
Match 4: 20 shots Rapid Fire at 25 yards
Match 5: .22 Caliber Aggregate

Center Fire Matches

- Match 6:** 20 shots Slow Fire at 50 yards
Match 7: National Match Course
Match 8: 20 shots Timed Fire at 25 yards
Match 9: 20 shots Rapid Fire at 25 yards
Match 10: .Center Fire Aggregate

12. **Classifications:** NRA classifications will be used. NRA Pistol rule 19 inclusive. New shooters who are not classified will be placed in a “New Shooter” classification.
13. **Awards:** Open winner in each individual match and in each aggregate will be awarded to the competitor with the highest score. First place awards will be awarded to competitors in each class having three or more shooters. Six or more shooters provide a second place and nine or more a third place. Unclassified competitors will shoot in a “New Shooter” class. Any class (except “New Shooter” class) that does not consist of three or more shooters, the competitor will compete in the next higher class. Awards will be NRA award coupons, cash or shooting equipment as determined by match staff. The number of competitors participating in the tournament will determine award schedule. Awards will be given out prior to the competitor departure from the range.
14. **Camping:** Full service RV Park available, \$15/night
